Athleta and Grand Slam Tennis Tours Australian Open Sweepstakes Official Rules

- 1. - **4. How to Enter:** During the Promotion Period, visit www.AthletaGSTTSweeps.com and follow the links and instructions to complete and submit the registration form including the email address associated with your Athleta Rewards membership. You automatically will receive one (1) Sweepstakes entry.

<u>Limit</u>: You may enter one (1) time per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. 5.
